By leaving a gift in your will to Another Europe you can be sure we'll continue to fight for the causes you believe in after you're gone. We promise to keep building the ground for a fairer, greener and more open society.

We wanted to help you plan your will with your solicitor, so we have put some helpful pointers in this document. Please discuss all details with your legal representative.

What you can give

Before you write your Will it's helpful to make a list of all your possessions and what you owe. Once you've got both figured out you will have a clearer picture of what you can leave.

What you own

Item / value

This should give you a better idea of what you have to give.

Family, friends and the causes you care about

Your family and friends come first when writing your Will. You can use the table below to make a list of what you want to give to the people in your life.

Once you've considered those important people, you can make sure we'll be there to fight for what you believe in once you're gone. What kinds of gifts you can make

Now you have an idea of what you have to give, it's worth taking a moment to think about the different kinds of gifts you can leave in your Will.

Residuary legacy

Once what you owe has been paid off, the residue of what you own will be left. A share of this is called a residuary legacy and it's usually made out as a percentage. Giving in this way makes the most of your gift as it keeps pace with inflation.

Pecuniary legacy

This is a gift of a specific sum of money, which remains set and isn't adjusted with inflation.

Specific legacy

This is a gift of a specific item you own, like shares, antique furniture, or jewellery.

What to write in your Will

If you decide to include a gift in your Will for us, please ask your solicitor to use the following wording so we can make sure it goes to supporting the campaigns you care so much about.

A share of your estate (residuary gift)

"I give to Another Europe is Possible Ltd, company number 10165201 of Housmans Bookshop, 5 Caledonian Road, London, England, N1 9DX the residue (or % share of the residue) of my estate and I direct that: i) The proceeds may be used for the general purposes of Another Europe is Possible and ii) A receipt signed by a person for the time being authorised by the Another Europe is Possible director shall be a good and sufficient discharge to my executors."

A specific sum (pecuniary gift)

"I give to Another Europe is Possible Ltd, company number 10165201 of Housmans Bookshop, 5 Caledonian Road, London, England, N1 9DX the sum of X of my estate and I direct that: i) The proceeds may be used for the general purposes of Another Europe is Possible and ii) A receipt signed by a person for the time being authorised by the Another Europe is Possible director shall be a good and sufficient discharge to my executors."

A specific item

"I give to Another Europe is Possible Ltd, company number 10165201 of Housmans Bookshop, 5 Caledonian Road, London, England, N1 9DX my _____and I direct that: i) such

assets may be sold and the proceeds used for the general purposes of Another Europe is Possible and ii) a receipt signed by a person for the time being authorised by the Another Europe is Possible director shall be a good and sufficient discharge to my executors."

Other important details - please read

Do these suggested draft clauses constitute a will?

No. These suggested clauses are not a will. Another Europe is Possible cannot give legal advice or help you with drafting your will. You should always seek the advice of a trusted solicitor. I already have a will. Is there a simple way to amend it?

If you already have a will it is possible that small changes to it can be accommodated by drafting a codicil, a legal document which is included with (but should not be attached to) the will. However, we would again strongly recommend taking professional advice from a solicitor if you plan to use this route – it may still be simpler to amend your existing will.

I live in Scotland. Are the rules around wills different here?

Yes, Scotland has a different legal system which impacts the law around wills and probate. Your solicitor will be able to advise you on what these differences mean for you.

Is my gift to Another Europe Is Possible tax deductible?

No, because we are not a registered charity. Another Europe Is Possible is a not-for-profit company. All the money we raise goes directly into campaigning on the causes we care about. Our current legal status provides us with the freedoms to undertake political campaigning on the issues our members support. This means that a gift left to us in an estate would not be deductible from inheritance tax, and would not therefore reduce any inheritance tax owed by the estate as a whole.
